## A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN CEZARINA WILLIAMS AND THE CITY OF SAN DIEGO

## RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On May 2, 2022, Cezarina Williams filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on September 23, 2021, at 3191 Commercial Street in San Diego. The lawsuit is entitled *Cezarina Williams v. City of San Diego*, San Diego Superior Court Case No. 37-2022-00016526-CU-PO-CTL (Litigation).

B. In closed session on February 24, 2025, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7, and 9; Nays, Districts 5 and 8; and Absent, None, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

### ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor of his designee to pay the sum of \$350,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation. 2. Authorizes the Chief Financial Officer to appropriate and expend an amount not

to exceed \$350,000.00 from Public Liability Fund No. 720045, for the purpose of settling this

Litigation.
